## 2005 WIND AND HAIL UPDATE SEMINARS

Announcing the . . . 2005 Wind and Hail Update Seminars! The Department of Insurance has approved the 2005 seminar for three (3) hours of South Carolina Continuing Education Credit.

The seminar will recertify your agency for the July 1, 2005 to June 30, 2007, time period. Certified Agencies will receive a 10% commission rate. Agencies that choose not to certify still have full access to the Association, but will receive a 5% commission rate.

Agencies with 50 or fewer policies need to send at least one licensed person to a seminar. Agencies with more than fifty policies need to send two or more licensed persons to a seminar.

**Seminar Topics...** The seminar will review the last two years, cover wind and hail basics, discuss common questions from producers, and present changes for 2005. Plus, we will have some fun and earn three hours of CE credit.
